Year-round savings: Technology Incentives Program



- As part of SDG&E's Demand Response portfolio this program is available to any commercial, industrial or agricultural customer with a monthly on-peak demand of 20kW or greater at their facilities for which the incentives are being requested.
- Businesses most likely to benefit are able to implement automated demand reduction measures (equipment or controls) in order to reduce their energy use, with minimal disruption to their core business, when an Event Day is called.


The Technology Incentives Program helps commercial customers bottom line by offering them incentives for the purchase and installation of qualified automated demand response measures (equipment or controls) that provide verified, dispatchable, on-peak load reduction at customerowned facilities.

Benefits for you and your business

- Reduced stress and increase savings: When an Event Day is called the system automatically implements the preprogrammed temporary load reduction plan to maximize the savings potential.
- Incentives help you save even more: The program offers up to two-hundred dollars (\$200.00/kW) of approved, installed and verified kilowatt (kW) reduction from a load shed test or 75% of the cost of installing enabling devices, whichever is less for Automated Demand Response (Auto-DR) measures. Only Auto-DR measures that meet open Auto-DR Standards will be considered eligible for incentives under this program.

Interested? Here's what to do next.

Customers who wish to receive technology incentives must demonstrate their actual ability to reduce demand and will be required to enroll in a qualified SDG&E® Demand Response program for a period of three years.



The Technology Incentives Program gives business customers, such as the Timken Museum in Balboa Park, financial incentives to install automated demand-response controls and equipment. This helps businesses manage energy use year-round and during demand-response events.
