### **INFORMATION ABOUT THIS APPLICATION**

On February 17, 2012, SDG&E filed its revised General Rate Case (GRC) Phase 2 application with the CPUC, asking for approval to change certain electric rates for its customers. The application proposes no changes to total revenue because revenue increases were requested and are being considered in SDG&E's Phase 1 GRC (A.10-12-005), filed on December 15, 2010. The current application proposes new revenue allocations and rate design that change how SDG&E allocates costs among our electric customers. Electric utility charges on your bill include revenues for transmission (the process of moving energy from one region to another), distribution (the process of delivering energy at the local level) and energy. Both electric distribution and electric energy rates are changed in this application. This application requests no changes to gas rates. As ordered

by the Commission, SDG&E's revised application removes the network use charge originally proposed to be implemented January 2014.
