The Technology Incentives Program provides participating businesses with incentives of \$200 per kW of verified load reduction or up to 75% of the cost of buying and installing automated energy management equipment and controls. Installing an automated energy management system at your business will give you a better way to manage daily energy use and help to:

- Reduce lighting use.
- Trim heating, ventilating and air conditioning (HVAC) usage.
- Better manage daily energy use for year-round savings.
- Earn additional incentives for participating in demand response programs.

To qualify:

- Your facility must have monthly on-peak demand of at least 20 kilowatts (kW) of electricity.
- The equipment or controls must provide verified, dispatchable, fully automated on-peak load reduction.

The incentive can range up to \$200 per kW of load reduction that meets these requirements, or a maximum of 75% of the total project cost.

Businesses, such as the Timken Museum in Balboa Park and the Marriott Marquis San Diego Marina, have participated in the program and now have the ability to make better informed decisions by monitoring, controlling and optimizing their daily energy use. Save more with an interest-free loan

Pay zero interest, with no money down, when you finance energy-efficiency projects through our On-Bill Financing Program. Monthly installments are based on estimated energy savings and included on your SDG&E® bill to minimize your upfront costs. Additionally, loans are calculated to be "bill neutral," meaning the expected monthly energy savings should offset the monthly loan installment.

Trade Professional Alliance, your trade professional can verify eligibility and submit applications for rebates, incentives and On-Bill Financing on your behalf.
