#### Enroll before March 31

If your business is enrolled in Direct Install by March 31, before pending program changes take effect, you could receive:

- An evaluation of your facility. Our authorized contractor will contact you to schedule an appointment at your convenience.
- A report on energy-saving opportunities. Our contractor will identify potential energy-saving opportunities and provide a full report.
- Replacement of eligible equipment at your facility. The contractor will install approved energy-efficient equipment, such as lighting, heating, ventilating and air-conditioning (HVAC), refrigeration and waterheating equipment.

#### Turn up the heat on savings with a smart thermostat

Your business also may qualify for free smart thermostats valued at \$300 each. With these smart thermostats, you can use your mobile device as a remote control to program and monitor temperature settings at multiple sites, modify occupancy schedules, and troubleshoot performance issues, which can help reduce the number of on-site service calls. 


