NOTICE OF SAN DIEGO GAS & ELECTRIC
COMPANY'S REQUEST TO
INCREASE ELECTRIC RATES FOR
ELECTRIC TRANSPORTATION PROGRAMS
(SENATE BILL 350)
APPLICATION NO. A.18-01-012

On January 19, 2018, San Diego Gas & Electric Company (SDG&E®) filed a request with the California Public Utilities Commission (CPUC) for approval to increase rates to fund programs that will help increase the use of medium-duty and heavy-duty electric vehicles. This request was made in response to Senate Bill (SB) 350, which ordered the CPUC¹ to direct electrical corporations to file applications for programs and investments to accelerate widespread transportation electrification. These program proposals will help reduce dependence on petroleum, meet air quality standards, achieve the goals set forth in the Charge Ahead California initiative, reduce emissions of greenhouse gases and reduce local air pollution.

The proposals include a multi-year program to install charging infrastructure for medium-duty and heavy-duty vehicles and equipment. The request also includes a vehicle-to-grid (V2G) pilot project that would use the batteries in electric school buses to provide storage services and power to the grid. These program proposals will accelerate transportation electrification by providing charging infrastructure to support participants seeking to deploy electric trucks, transit buses, school buses, and equipment, such as electric forklifts. Additionally, the V2G pilot project would charge electric school buses mid-day to store excess renewable power and discharge the power in the evening hours when it is beneficial to the grid.

The requested rate increase covers costs associated with implementing these program proposals. Costs include (but are not limited to) charging equipment and installation, electrical infrastructure for charging stations, customer support, and staff necessary for equipment, maintenance and billing support. The total costs of the proposed projects are approximately \$222.9 million. The cost to ratepayers over the first three years will be an increase of \$5.7 million in 2020, an increase of \$11.5 million in 2021, and an increase of \$18.7 million in 2022.

The charts shown below illustrate the changes in rates that would result from CPUC approval of this application, compared to current rate levels.

ILLUSTRATIVE IMPACT ON ELECTRIC RATES AND BILLS

If the CPUC approves SDG&E’s request, a typical non-CARE residential customer living in both the inland and coastal climate zones and using 500 kilowatt-hours per month could see an annual bill increase in 2020 of \$2.28, or 0.1%. A typical current monthly bill could increase from \$160.70 to \$160.89. The percentages shown do not necessarily reflect the changes that you may see on your bill. Changes in individual bills will also depend on how much electricity each customer uses.

CPUC PROCESS

This application will be assigned to an Administrative Law Judge (Judge) who will determine how to receive evidence and other related documents, necessary for the CPUC to establish a record upon which to base its decision. Evidentiary hearings may be held where parties of record will present their testimony and may be subject to cross-examination by other parties. These evidentiary hearings are open to the public, but only those who are parties of record can participate.

After considering all proposals and evidence presented during the formal hearing process, the assigned Judge will issue a proposed decision which may adopt SDG&E’s proposal, modify it or deny it. Any CPUC Commissioner may sponsor an alternate decision. The proposed decision, and any alternate decisions, will be discussed and voted upon at a scheduled CPUC Voting Meeting.

The Office of Ratepayer Advocates (ORA) may review this application. ORA is the independent consumer advocate within the CPUC with a legislative mandate to represent investor-owned

utility customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. ORA has a multi-disciplinary staff with expertise in economics, finance, accounting and engineering.
