

Teaming up with community groups to support cybersecurity

Whether you're shopping online or running a business, visiting social sites or paying bills, it's important to keep your information secure. To help build a safer community that includes cyber neighborhoods, SDG&E® collaborates with local nonprofit groups that offer cybersecurity education and assistance. Among the current partners are three based in San Diego:

- **Identity Theft Resource Center** provides 24-hour assistance at no cost to people throughout the U.S. who need help resolving identity theft issues. The center also offers practical information on recognizing and protecting against identity theft and scams.

- **Securing Our eCity Foundation** offers free workshops and information to facilitate cyber safety for the greater San Diego community, particularly



youths and small and mid-sized businesses. Volunteers can participate in workgroups, activities and events.

- **San Diego Police Foundation's SafetyNet: Smart Cyber Choices®** program teaches kids the responsible use of technology. It has provided cyber safety training to more than 120,000

middle school students, 11,000 parents and 4,200 educators.

Some materials found at our facilities and work sites contain substances on the state's list of substances known to cause cancer or reproductive harm. We handle all materials carefully for your good health as well as ours; however, exposure to substances on the state's list may occur at these locations.
