On January 20, 2017, San Diego Gas & Electric Company (SDG&E®) filed a request with the California Public Utilities Commission (CPUC) for approval to increase rates to fund projects and programs that will help increase the use of electric transportation. This request was made after the CPUC issued a ruling directing SDG&E to file its first transportation electrification application as mandated by Senate Bill (SB) 350. SB 350 orders the CPUC, along with the help of the California Air Resources Board and the California Energy Commission, to direct electrical corporations to file applications for programs and investments to accelerate widespread transportation electrification. These projects and programs will help reduce dependence on petroleum, meet air quality standards, achieve the goals set forth in the Charge Ahead California, and reduce emissions of greenhouse gases.

The project proposals include a multi-year program to install charging infrastructure from 2020-2026 in residential homes. This application also includes six one-year pilot projects that would involve installing charging infrastructures at targeted public and commercial locations as well as providing education and incentives to dealerships. These proposals will accelerate transportation electrification by providing charging infrastructure to support light, medium and heavy duty electric vehicles (passenger vehicles, taxis, fleet, airport ground support equipment, and forklifts). These proposals will also include data collection and analysis of electric vehicle grid impacts as well as education and incentives to enhance electric vehicle sales. The requested rate increase covers costs associated with implementing the SB 350 transportation electrification projects. Costs include (but are not limited to) charging equipment and installation, electrical infrastructure for charging stations, labor for measurement evaluation and customer support, and staff necessary for equipment, maintenance and billing support. The total costs of the proposed projects and programs are approximately \$416.4 million. The cost to ratepayers over the first three years will be a decrease of \$(2.3) million in 2018, a decrease of \$(2.9) million in 2019, and an increase of \$22.7 million in 2020.

SB 350 RATE PROPOSALS

This application includes new residential (whole-house) rates, new commercial rates, and new public charging rates for customers participating in the transportation electrification projects proposed in this filing. These rates are designed to accelerate the growth of transportation electrification by ensuring efficient integration of electric vehicle loads with the electric grid. These proposed rates will also be optionally available to all customers and will vary hour by hour and incorporate the most current pricing information available on a day-ahead basis. These hourly prices will include a premium added to top peak hours both on a system and local level.

The new rate proposals are intended to meet the distinct needs of electric vehicle customers, support electric vehicle charging at residential, public and commercial locations, and provide a pricing structure that will support the increased amount of electric vehicles in the region. The rates will provide benefits for customers who charge in a manner consistent with electrical grid conditions.

The charts shown below illustrate the changes in rates that would result from CPUC approval of this application, compared to current rate levels.

ILLUSTRATIVE INCREASE ON ELECTRIC RATES AND BILLS

If the CPUC approves SDG&E's request, a typical non-CARE residential customer living in the inland climate zone and using 500 kilowatt-hours per month could see a monthly summer bill increase in 2020 of \$0.71, or 0.6%. A typical current monthly bill could increase from \$123.00 to \$123.71. The percentages shown do not necessarily reflect the changes that you may see on your bill. Changes in individual bills will also depend on how much electricity each customer uses.

CPUC PROCESS

This application will be assigned to an Administrative Law Judge (Judge) who will determine how to receive evidence and other related documents, necessary for the CPUC to establish a record upon which to base its decision. Evidentiary hearings may be held where parties of record will present their testimony and may be subject to cross-examination by other parties. These evidentiary hearings are open to the public, but only those who are parties of record can participate.

After considering all proposals and evidence presented during the formal hearing process, the assigned Judge will issue a proposed decision which may adopt SDG&E's proposal, modify it or deny it. Any CPUC Commissioner may sponsor an alternate decision. The proposed decision, and any alternate decisions, will be discussed and voted upon at a scheduled CPUC Voting Meeting.

The Office of Ratepayer Advocates (ORA) may review this application. ORA is the independent consumer advocate within the CPUC with a legislative mandate to represent investorowned utility customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. ORA has a multi-disciplinary staff with expertise in economics, finance, accounting and engineering.
