EcoShareSM allows customers to work directly with renewable energy developers and purchase the rights to a portion of the electric output from a new local renewable generating facility. Customers enter into a private agreement with the developer, known as a "Customer-Developer Agreement" (CDA), where the electricity price and agreement terms are defined.

Customers participating in EcoShare will receive a credit on their SDG&E bill reflective of the amount of renewable energy purchased through the developer. **The price**, **terms**, **and conditions summarized here are for the SDG&E bill credit only**.

How do I enroll in EcoShare?

You must first have a Customer-Developer Agreement in place with a renewable energy developer outlining your subscription to a EcoShare project. When the project nears operational status, or if it has already achieved operational status, you will enroll through the developer in SDG&E's EcoShare program.

How will I be billed for EcoShare?

You will receive a <u>net credit</u> on your monthly SDG&E electricity bill proportional to your participation in EcoShare (Schedule ECR).

You will be billed separately from the renewable energy developer for your subscribed portion of the renewable generating facility according to the terms of your Customer-Developer Agreement.

How will the EcoShare credit be calculated?

After enrolling in EcoShare, you will notice two additional line items on your monthly SDG&E bill:

1. EcoShare Bill Credit

The EcoShare Bill Credit includes the following charges and credits:

- 1. Renewable Energy Value Adjustment
- 2. Administrative and Marketing Costs
- 3. SDG&E's Average Commodity Cost Adjustment
- 4. California Independent System Operators (CAISO) Grid Management Charges (GMCs)
- 5. Western Renewable Energy Generation Information System (WREGIS) Charges

2. Power Charge Indifference Adjustment (PCIA)

The PCIA comprises the above market costs of SDG&E's existing procurement portfolio and is calculated annually. This is a cost that is ultimately borne by all customers for resources procured on their behalf.

The PCIA will be applied based on the date that you begin service on the EcoShare schedule. If you begin service in the first six months of the calendar year (e.g. 2018), you are assigned the prior year's vintage (i.e. 2017). If you begin service on or after July 1, you are assigned the vintage for the current year (2018 in this example).

The net EcoShare credit will be applied on a per kWh basis to your enrolled monthly electricity usage, which is defined in the terms of your Customer-Developer Agreement. Applicable federal, state, and local taxes and charges still apply.

Will my rate change over time?

EcoShare bill credits and charges on your SDG&E bill are based on current California Public Utility Commission approved tariffs. *Charges and credits are subject to change annually as approved by the California Public Utilities Commission.* You will be provided an annual summary of current program charges and will be notified whenever significant changes to price occur.

SDG&E does not review the Customer-Developer Agreement, which may contain terms that cause the rate charged to you to change over time.

What other fees might I be charged?

There are no other recurring fees charged by SDG&E, but termination fees may apply as outlined below. You will receive a separate bill from the renewable energy developer pursuant to the terms of your Customer-Developer Agreement.

What length of agreement is required?

SDG&E will require a minimum one (1) year term for participation in EcoShare. You will continue to be enrolled in the program after the first year on a monthly basis. If you terminate your participation in EcoShare, you may not re-enroll in the program for a one-year period beginning on your withdrawal date.

Additional enrollment terms may be contained in your Customer-Developer Agreement.

Can I cancel my participation and are there any termination fees?

Yes. You will have 60 days, beginning on your effective date of enrollment, to cancel your participation in EcoShare for any reason without being charged an early termination fee. The cancellation will become effective on your next closed bill period after the termination request is processed.

If you elect to cancel after the 60-day grace period but prior to the end of the one-year agreement term, you will be charged a termination fee.

Residential Customers: A termination fee of \$80.00 will be charged.

<u>Business Customers:</u> The termination fee for business customers is based on average monthly enrolled consumption, and decreases month over month as you move towards the end of the one-year enrollment term:

Termination Fee =

\$0.01016 * (Average Monthly Enrolled Consumption) * (Number of Months Remaining in Initial 1 Year Term)

Your Customer-Developer Agreement may have additional cancellation terms.

Can I move and continue to participate in EcoShare?

Yes, enrollment is fully transferable to your new premises or account, provided that the new premises or account is located within SDG&E's service territory. As part of your transfer of service (moving to a new location), you should let SDG&E know when and where the existing enrollment should be transferred to. Eligibility of the new premise or account will be determined before transfer of the rate is completed.

Please refer to your Customer-Developer Agreement for additional requirements regarding transfer of service.

Can I participate in both EcoShare & EcoChoiceSM programs at the same time?

Can I participate in No, a single account may not be enrolled in both programs at the same time.

What is SDG&E's default resource mix?

The current average mix of resources supplying SDG&E customers includes: Biomass and Biowaste (1%), Solar (21%), Wind (21%), Natural Gas (42%), and Other (15%). This resource mix was reported in SDG&E's 2016 Power Content Label. Renewables contained in SDG&E's default resource mix are not Green-e certified.
